



Letter from the CEO and Chairman of the Board

We are incredibly proud to celebrate Emgage's 15 year anniversary! Since our founding, our focus remains on building Muslim American civic participation by educating and mobilizing voters. We feel blessed to be able to continue on this journey with you and are excited to share our latest accomplishments.

Following an incredible 2020 cycle, where Emgage's Million Muslim Votes campaign helped turn-out over one million Muslim voters, we knew that our work must continue. In 2021, we worked to ensure that our hard work in getting voters to the polls translated into meaningful policies and a new culture of inclusivity. To this end, Emgage helped incubate a first-ofits-kind community collaboration effort to champion Muslim American professionals for appointments in the Executive Branch. Emgage and a core group of Muslim civic organizations supported an intensive process of soliciting, reviewing, and recommending Muslim American names to the White House Presidential Personnel Office for appointments throughout the Interagency. With the coordination, acumen, and support of the El Hibri Foundation, the effort grew to include 47 Muslim American national and community organizations. Thanks to this collaboration, numerous qualified Muslim American candidates were recommended, with a historic number now serving in the Biden administration in areas ranging from national security to economic affairs to public health. Ensuring that our interests are represented in policy-making is a core priority for Emgage. We are committed to this and other efforts that are aimed at championing qualified representation in the halls of government.

Emgage was at the forefront of other initiatives aimed at engaging with the administration so that Muslim Americans could be at the decision-making table. We engaged with the White House and key agencies on a regular basis on critical issues. Emgage participated in weekly White House meetings with the faith community where we provided input and feedback on major priorities of the administration, including the Build Back Better program, the Infrastructure Bill, and COVID-19 response. Emgage's expertise in policy analysis and advocacy was leveraged to assess community equities in various policies of the administration. We provided valuable input to ensure that our community's interests were represented.

Understanding that we are stronger when we collaborate, Emgage ensured that a broad set of Muslim American organizations were included. Emgage sought to facilitate the engagement of the Muslim American community in the deliberation of policies, including by facilitating administration engagement on issues including confronting white supremacy, Supreme Court appointments, and protecting human rights abroad. Additionally, Emgage supported the historic campaign to confirm the nation's first Black female Supreme Court Justice, Ketanji Brown Jackson. We know that Justice Jackson shares many of our community's values, so we are proud to see her arbitrate some of our nation's most pressing issues.

At the state level, we educated and connected constituents with elected officials. Our Michigan chapter had its first virtual advocacy day, during which they hosted the Governor, Secretary of State, and Attorney General to discuss criminal justice reform, COVID-19 response, and voting rights. In New York, our team hosted its first Muslim Day at City Hall, a virtual conference in which over thirty city council members and their staff discussed civil rights and incarceration, social services, domestic violence, immigration, small business growth, and youth empowerment. Our Pennsylvania and Florida chapters held similar civic engagements including townhalls and iftars to promote engagement between Muslim American communities and their elected officials.

Our chapters also focused on redistricting to ensure that minority voters were properly represented. Our Michigan team submitted three maps to the Michigan Independent Redistricting Commission, and urged them to keep Muslim communities together while redrawing State House, State Senate, and Congressional maps. In Texas, our team provided extensive legislative testimony showing that redistricting in the state was racially motivated and rooted in voter suppression.

We are so proud of the incredible work that our national and state chapters have done to ensure that Muslim American communities are an empowered, civically engaged community– and that we are fairly represented in government and policy-making processes.







MICHIGAN

Redistricting

Following the 2018 midterm elections, Michigan voters changed the redistricting process by adopting Proposal 2. This proposal transferred the power to a non-partisan commission called the Michigan Independent Citizens Redistricting Commission (MICRC). With this shift, the MICRC became responsible for drawing the district lines for Michigan's U.S. Congressional Representatives, State Senate, and State House.

In 2021, Emgage Michigan focused on redistricting because of its impact on our community's representation. Our chapter submitted three maps to the MICRC and urged them to keep our communities together while redrawing State, House, and Congressional districts. We also provided numerous community testimonies, an educational town hall, and worked on a digital campaign to draw public support for our maps.

Although the maps were not perfect, Emgage Michigan was instrumental in influencing the commission to keep our Muslim communities in the following districts: Congressional District 12, State Districts 2 and 3, and House Districts 3, 9 and 15.



From January through November 2021, Emgage Texas, in collaboration with Houston in Action and Fair Maps Texas, actively participated in redistricting advocacy and provided testimony during state and county redistricting sessions. Our work and testimonies focused on how redistricting was rooted in voter suppression, ignored racial minorities, and prevented communities of color from electing candidates of their choice.

The Texas legislature convenes for a regular session for five months every other year. In 2021, Texas had a regularly scheduled legislative session that ended May 31, 2021; Texas legislators also returned to Austin for three special sessions between July to October. Throughout the four sessions, the legislature passed hundreds of laws including voting restrictions, topic-specific curriculum bans, abortion restrictions, and redistricting bills.

Democratic lawmakers walked out of legislative session twice in protest of new, suppressive voting laws. Ultimately, a revised bill called SB 1 passed; it makes restrictive changes to voting and elections, such as banning overnight early voting hours, drive-thru voting, and dropboxes for mail-in ballots. Local election officials also would be committing a state jail felony if they promote mail-in ballot submission as a voting option or distribute mail-in ballot applications to voters or groups assisting voters. This penalty, as well as a civil fine, apply even if the voters in question automatically qualify to vote by mail.

The Texas legislature also completed the redistricting process for State House, State Senate, and Congressional districts. Emgage Texas repeatedly provided testimony in person and in writing, and created and disseminated educational materials on redistricting to make community participation accessible. The Texas legislature ultimately passed maps Emgage Texas and other members of the Fair Maps coalition advocated against. Emgage currently is a plaintiff in a lawsuit challenging districts in several counties on the basis of racial gerrymandering by state lawmakers.



On the county level, Harris County underwent its redistricting process to reassign commissioners based on census data and community need. Emgage Texas worked in coalition with Houston in Action to map communities of interest for redistricting at the precinct level and present them to Commissioners Court. Our coalition mapping process included community conversations identifying infrastructural needs such as flood concerns, community demographics, and migration patterns. We worked in collaboration with organizations such as Mi Familia Vota and Pure Justice to ensure that the community maps we built through this process were representative and intersectional.

> Emgage Texas also provided testimony regarding redistricting processes for Fort Bend County, another county with a substantial Muslim population. We advocated against maps proposed by the Fort Bend Commissioners Court that split MASA and MENA populations, and testified on behalf of the Muslim community in favor of keeping masjids and the areas where congregants lived around them together.



CHAPTER HIGHLIGHTS VIRGINIA

In 2021, Emgage Virginia continued with its long-term strategy of increasing Muslim voter participation. The Virginia team played a major role in increasing Muslim voter turnout by 5% statewide in 2021. Throughout the year, our team collected over 49,206 pledges to vote through a coordinated effort to reaching our community. The team made a total of 201,501 calls, sent over 250,000 text messages, and knocked on over 10,000 doors in Virginia in order to get out the vote.

PENNSYLVANIA

This year, Emgage Pennsylvania prioritized connecting Pennsylvanian Muslims to their elected officials. To this end, we hosted a virtual meeting with multiple state legislators, including State Senator Sharif Street (D-PA-3), State Senator Carolyn Commita (D-PA-19), and State Representative Melissa Shusterman (D-PA-157). The panel also included our board members, including Abdul Mughees Chaudhri, Rabiul Chowdhury, Sherrine Eid, and Asif Ilyas. In addition, several local Muslim spiritual and business leaders were in attendance. They discussed key issues including the protection of our elections and the democratic process, civil justice, and religious tolerance. The event helped our local Muslim American community across

Pennsylvania create a dialogue with our political leaders. Further, this allowed our community to see how Emgage interfaces with our political leaders to inform policy-making.

Furthermore, we took part in a number of meetings with elected officials and policymakers, during which we discussed matters such as voting rights, fair funding for schools, mandatory minimums, criminal justice reform, equity in health care, removing school resource officers, advocacy for Muslim students, Eid holiday recognition, access to halal meals in schools, and increasing small business opportunities for Muslim entrepreneurs.



CHAPTER HIGHLIGH PENNSYLVAN

Emgage PA convened a number of engagements with elected officials, including State Senator Anthony Hardy Williams, State Representative Joanna **McClinton, Congressman Dwight Evans** (represented by Chief of Staff, Anuj Gupta), State Senator Art Haywood, and State Representative Darisha K. Parker.

Additionally, we joined coalitions and partnerships in support of voter access and

participation across Pennsylvania. We participated in Black Voters Matter PA Chapter weekly table meetings and strategic planning sessions, during which we engaged with other civic engagement organizations on expanding voter turnout and voting rights. Our team also secured a partnership with PA Voices' civic engagement table, through which we were able to establish a Get Out The Vote (GOTV) operation, which included voter registration, door

canvassing, and phone and text banking.

We also participated in All Voting is Local organization's weekly table meetings and strategic planning sessions regarding increasing voter participation in Philadelphia County. Some of our key takeaways from these meetings were that simple bureaucratic decisions, such as how states keep registration lists current and where counties close polling places, deny the fundamental right to vote, causing real harm to real people. Time and

again, the people shut out of our democracy are those that have long been disenfranchised: communities of color, young people, lowincome Americans, and voters with disabilities. As a result, we are coming together — across race, zip codes, and backgrounds — to demand that every eligible American has the freedom to vote. We were honored to receive a partnership grant from All Voting is Local to continue forth with this critical work.

We invested much of our energy in hosting five community-building events, town-hall events, voter education forums, a candidate forum for the 20th congressional district with all seven candidates attending, three food packing events, and many interfaith meetings and masjid family nights. We invited elected officials to engage with us and join us during these initiatives.

Our team also created GOTV programs to increase turnout for local elections, and distributed voter registration fliers to businesses and religious centers in six counties throughout the state. We handed out voter fliers in partnership with our Emerging Leaders programs on election days. We worked with supervisors of elections and elected officials to promote voter registration, and collaborated with coalition groups to encourage voter education and promote more inclusive voting policies. Further, we worked in civic committees to encourage citizens to run for public office.

Our team used various forms of technology and media to increase voter turnout through over 100,000 text blasts, over 200,000 phone calls, thousands of emails, and dozens of social media promotions. This helped contribute to a 9.5% increase in turnout compared to similar

local and municipal elections prior.

Our year-long journey culminated in a month-long initiative to coordinate and attend ten Ramadan iftar dinners and two town halls throughout the state, which connected elected officials with civic leaders and community members to encourage voter registration and civic duty within the **Muslim American** community.

NEW YORK METRO

As the newest chapter of Emgage, we knew we had to hit the ground running in order to serve the vast needs of diverse Muslim communities in the New York Metro area. We saw our chapter's Senior Advisor, Dr. Debbie Almontaser, become one of the first Muslim women to provide a prayer at the Presidential Inauguration Service. Further, we consistently

connected our community with elected officials. A key example of this was our fireside chat with New York State Senator Robert Jackson and New York Assembly Member Charles Fall, during which they both discussed their personal stories and how they got involved in politics. Furthermore, our team supported national events, including phone banking in Georgia and Pennsylvania for the Senate run-off races.

A major milestone that our team accomplished this year was our first **Muslim Day at City Hall**, a virtual conference in which over thirty city council members and their staff attended a set of briefings that we organized. During this meeting, thirteen Muslim non-profit organizations discussed the challenges Muslim New Yorkers face, and made direct asks and recomendations of the city council. The topics we presented were identified by participating organizations who represent our community and understand their direct needs. It was a powerful briefing where council members had the opportunity to learn more about the most pressing issues affecting our community. The key issue areas that we focused on were: civil rights and incarceration, social services, domestic violence, immigration, small business growth, and community education and youth empowerment. Our goal continues to be bridging the gap between policy-makers and Muslim New Yorkers to create a more civically engaged community.

CHAPTER HIGHLIGHTS NEWYORK METRO

Emgage New York Metro worked with city and state legislatures and city agencies to pass legislation on halal food certification to ensure food equity for Muslim New Yorkers. We met with city council central staff, key city council members, the Mayor's Office of Food Policy, and the Mayor's Office of Contract Services to ask the city to provide appropriate halal food options for our community. We asked them to review current contracts and vet vendors serving halal food who do not meet appropriate halal guidelines. We advocated for the city to utilize Halal World Watch, which is recognized by NYC Muslim leadership and is an affiliate of the U.S. Department of Halal Standards. On a state level, we advocated for a Halal Food Protection office with expert halal food scholars and full-time staff to enforce updated guidelines of World Halal Watch as the verifying Halal certification body for halal certification. We have also asked for halal meals funding and for the expansion of halal meal programs in school districts with large Muslim populations.

Our team continues to work with city and state officials to expand and regulate certifications of halal meal programs, create a certifying body that includes members of our community, and ensure that guidelines follow appropriate halal standards.

A month before swearing into office, Mayor Eric Adams and other elected officials created numerous transition teams for their administrations to address the most pressing issues facing New York City. Our team's Senior Advisor Dr. Debbie Almontaser served on six key transition teams. She was one of the cochairs of the Equity Committee, and a member of the Food Policy Committee for Mayor Adams. She also served on Comptroller Brad Lander's transition team. She was a member of the Faith-based Committee for Manhattan DA Alvin Bragg, Economic Development, Job Creation, and Borough Advocacy Committee for Manhattan Borough President Mark Levin, and the Education and Youth Development

Committee for Brooklyn Borough President Antonio Reynoso. Her work on each of these committees ensures that Muslim American voices are included as important policy decisions are formulated.

Asks & Recommendations

- We ask that NYC Council recognizes Muslim women, youth and seniors affected by domestic violence as a group and set aside funding to meet their growing needs.
- The number of DV related incidents and crimes have spiked during the pandemic. Muslim women have bee insurmountable challenges and need our support.
- Community-based nonprofits providing culturally/religiously sensitive services must get more fund meet the challenges they confront on a daily basis.
- Additionally, the needs of Muslim youth and seniors must be kept front and center. We know that elder above and abuse of youth (both within homes and outside) is rampant. Funds are badly needed in both these areas if we are to address the isolation and loss of hope among our youth and senior women due to the pandemic.
- Access to digital devices and computer literacy is critical for survivors of domestic violence and helps to ensure the safety of Musaim women of all ages.
- Financial support for legal services for domestic violence survivors and culturally competent organizations:
- · Access to safe and affordable housing for survivors.




